Requirements

Requirements for Change of License Activity / Category

1. SAIF ZONE application form ***duly typed, signed & stamped*** for License Amendments.
2. **Board Resolution** signed by all the Shareholders of the company (to be supported by POA or initial board resolution authorizing the signatory(s) for respective amendment if applicable). *In case of new board resolution for branch & subsidiary companies, must be attested from embassy in country of origin & MOFA in UAE.*
3. **Project summary** for proposed new category/activity.
4. Original license (With old activity) has to be returned (if valid).
5. **Health Section approval** is required for all Industrial license (new/additional/amendments) – (L2 Building, 1st floor)
6. **Department of Civil Aviation dept.** approval is required for Aviation related license (new/additional/amendments).
7. **Fees Payable:-**
 - a. If the current license is expired then full amount should be paid.
 - b. If the license is not expired then difference amount as per prorata for upgrading of *license category* to be paid. No credit applicable for the fee paid against earlier license.
 - c. If the license is not expired then amendment fees of **Dhs. 1000/-** will be charged to *amend the activity within same category* (License expiry date will not be changed).
